and Recommending Award of Contract for the

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to **six (6)** bonafide local suppliers namely: **SAL'S BAR AND RESTAURANT, SOPHIA'S WAY CATERINGS SERVICES, CAFÉ MARGA, C PAVILION, HOTEL CONSUELO, AND HOTEL ALEJANDRO** thru **Negotiated-Small Value Procurement** with a total **Approved Budget** for the **Contract (ABC) of ₱ 139,800.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above mentioned suppliers;

WHEREAS, in response to the said request, only four (4) suppliers namely **SAL'S BAR AND RESTAURANT, SOPHIA'S WAY CATERINGS SERVICES, CAFÉ MARGA** and **C PAVILION** submitted its quotation within the deadline of bid submission; While **HOTEL CONSUELO AND HOTEL ALEJANDRO** only received the RFQ but did not submit quotation.

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **CAFÉ MARGA** was found to have offered the **Lowest Calculated and Responsive Bid**, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **CAFÉ MARGA** as the bidder with the **Lowest Calculated and Responsive Bid** for the **“Supply and Delivery of Packed Meals for the In-House Upskilling Course on LGU-PFM on Nov. 22, 2024, LGU SUMMIT on Nov. 25, 2024, and Break-Out Sessions from Nov. 27, 28, 29 & Dec. 2, 3, 4, 5, 2024”** and Recommend award of contract to the said supplier with a total contract price of **₱ 137,510.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.


