**BAC Resolution Declaring Lowest Calculated and Responsive Bid,  
and Recommending Award of Contract for the  
“CATERING SERVICES FOR THE REGIONAL PLANNING FORUM ON OCTOBER 8-11,  
2024”**

**RESOLUTION No. 2024-10-053**

**WHEREAS**, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to five (5) bonafide local suppliers namely: SAL'S BAR AND RESTAURANT, SOPHIA'S WAY FOOD CENTER, CAFÉ MARGA, HOTEL CONSUELO AND C PAVILION for the “**CATERING SERVICES FOR THE REGIONAL PLANNING FORUM ON OCTOBER 8-11, 2024**” thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱136,800.00**.

**WHEREAS**, the RFQs were duly acknowledged and received by the above suppliers;

**WHEREAS**, in response to the said request, all except Hotel Consuelo submitted their quotation within the deadline of bid submission;

**WHEREAS**, two other suppliers namely RYEONETH CATERING SERVICES AND RESTAURANT and KIARA'S FOODHAUS have hand-carried their RFQs and were received at the DBM Regional Office VIII also within deadline of bid submission;

**WHEREAS**, the quotations received were evaluated by the Committee on a “per lot” basis;

**WHEREAS**, upon careful examination of the quoted/bid, **KIARA'S FOODHAUS** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

**WHEREAS**, the Bids and Awards Committee further verified on the performance delivery of the said supplier in some agencies thru phone calls particularly NIA and COA and both offices provided positive feedbacks/comments;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **KIARA'S FOODHAUS** as the bidder with the Lowest Calculated and Responsive Bid for the “**CATERING SERVICES FOR THE REGIONAL PLANNING FORUM ON OCTOBER 8-11, 2024**” and Recommend award of contract to the said supplier with a total contract price of **₱120,800.00**.
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and

c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
