**BAC Resolution Declaring Single Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Supply and Delivery of Glass Plaques for the Regional Planning Forum
on October 8-11, 2024”**

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **TACLOBAN MABUHAY GLASS SUPPLY, STARLITE GLASS AND ALUMINUM SUPPLY, and NEW GLORY GLASS AND ALUMINUM SUPPLY** for the “Supply and Delivery of Glass Plaques for the Regional Planning Forum on October 8-11, 2024” thru Negotiated-Small Value Procurement with a total **Approved Budget for the Contract (ABC) of ₱30,800.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, all suppliers submitted quotation within the deadline of bid submission;

WHEREAS, Starlite Glass and Aluminum Supply and New Glory Glass and Aluminum Supply indicated ‘None’ on the submitted quotation;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **TACLOBAN MABUHAY GLASS SUPPLY** was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **TACLOBAN MABUHAY GLASS SUPPLY** as the bidder with the Single Calculated and Responsive Bid for the “Supply and Delivery of Glass Plaques for the Regional Planning Forum on October 8-11, 2024” and Recommend award of contract to the said supplier with a total contract price of **₱30,800.00**.
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
