**BAC Resolution Declaring Single Calculated and Responsive Bid,
and Recommending Award of Contract for the "Procurement of Packed Meals for the
IQA on December 10, 2024 and Year-End Assessment on December 11-12, 2024"**

RESOLUTION No. 2024-12-068

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to five (5) bonafide local suppliers namely: **SOPHIA'S WAY FOOD CENTER, CAFÉ MARGA, C PAVILION, HOTEL CONSUELO, and HOTEL ALEJANDRO** for the "Procurement of Packed Meals for the IQA on December 10, 2024 and Year-End Assessment on December 11-12, 2024" thru Negotiated-Small Value Procurement with a total **Approved Budget for the Contract (ABC) of ₱64,800.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above mentioned five (5) suppliers;

WHEREAS, in response to the said request, only **SOPHIA'S WAY FOOD CENTER, CAFÉ MARGA, and C PAVILION** submitted their quotation within the deadline of bid submission;

WHEREAS, the quotations received were evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, **CAFÉ MARGA** was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

WHEREAS, due to the postponement of the Internal Quality Audit (IQA) on December 10, 2024, the awarded contract price only covers the packed meals for the Year-End Assessment on December 11 and 12, 2024;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **CAFÉ MARGA** as the bidder with the Single Calculated and Responsive Bid for the "**Procurement of Packed Meals for the IQA on December 10, 2024 and Year-End Assessment on December 11-12, 2024**" and Recommend award of contract to the said supplier with a total contract price of **₱42,480.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
