**BAC Resolution Declaring Single Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Delivery of Security Services for December 1-31, 2024”**

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **VISION SECURITY SERVICES, INC, TCO SECURITY AGENCY, and METROGLOBAL SECURITY** for the “**Delivery of Security Services for December 1-31, 2024**” thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱96,783.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, only **VISION SECURITY SERVICES, INC.** submitted its quotation within the deadline of bid submission.

WHEREAS, **TCO SECURITY AGENCY** and **METROGLOBAL SECURITY** did not submit bid quotation;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **VISION SECURITY SERVICES, INC** was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **VISION SECURITY SERVICES, INC** as the bidder with the Single Calculated and Responsive Bid for the “**Delivery of Security Services for December 1-31, 2024**” and Recommend award of contract to the said supplier with a total contract price of **₱96,782.01**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
