WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to four (4) bonafide local suppliers namely: **NEW FIVE STAR TRADING AND PRINTING PRESS, PIXELENZ PRINTING SUPPLIES ENTERPRISES, TRES NIÑAS GENERAL MERCHANT AND PRINTING, and FMK OFFICE AND SCHOOL SUPPLIES** for the **"Supply and Delivery of 2024 GAD Planner"** thru **Negotiated-Small Value Procurement** with a total **Approved Budget for the Contract (ABC) of ₱108,000.00**.

- a.) To declare **TRES NIÑAS GENERAL MERCHANT AND PRINTING** as the bidder with the Lowest Calculated and Responsive Bid for **Supply and Delivery of 2024 GAD Planner**, and Recommend award of contract to the said supplier with a total contract price of **₱106,000.00**;
- b.) To specify in the **Notice of Award (NOA)** that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
