**BAC Resolution Declaring Lowest Calculated and Responsive Bid and

WHEREAS, the Department of Budget and Management ROVIII thru its Bids and Awards Committee (BAC) has conducted procurement activities for the project “Delivery of Janitorial Services” with a total ABC of ₱645,870 thru competitive public bidding;

WHEREAS, two (2) suppliers purchased the bid documents and subsequently submitted their respective bid within the deadline of submission on December 27, 2023, namely, Vision Janitorial and Allied Services and A & B Multi Serv Corporation;

WHEREAS, both suppliers passed the preliminary and detailed evaluation of bids conducted by the Committee last December 27, 2023, subject to post qualification process specifically the lowest calculated bid, to wit:


