**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Catering Services for the Conduct of Orientation on the Preparation, Submission,

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to five (5) bonafide local suppliers namely: **SAL’S BAR AND RESTAURANT, SOPHIA’S WAY FOOD CENTER, SEFREM EVENT CATERING SERVICES, C PAVILION, and HOTEL CONSUELO** for the “Catering Services for the Conduct of Orientation on the Preparation, Submission, Evaluation, and Review of Corporate Operating Budget of Local Water Districts and Agency Performance Review Consultation” thru **Negotiated-Small Value Procurement (SVP)** with a total **Approved Budget for the Contract (ABC)** of **₱166,500.00**;

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, ALL have submitted their quotation within the deadline of bid submission;

WHEREAS, HOTEL CONSUELO likewise submitted their quotation manually/on-site within the deadline of bid submission based on the RFQ posted in the PhilGEPS;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **SOFIA’S WAY FOOD CENTER** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **SOFIA’S WAY FOOD CENTER** as the bidder with the Lowest Calculated and Responsive Bid for the “Catering Services for the Conduct of Orientation on the Preparation, Submission, Evaluation, and Review of Corporate Operating Budget of Local Water Districts and Agency Performance Review Consultation” and Recommend award of contract to the said supplier with a total contract price of **₱156,640.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
