**BAC Resolution Declaring Single Calculated and Responsive Bid,  
and Recommending Award of Contract for the  
“Supply, Delivery, Installation, Commissioning, and Testing of Cistern Tank, Water  
Pump and its Accessories, and Replacement of Sideport(SP)-21 Pressure Tank”**

**RESOLUTION No. 2024-04-025**

**WHEREAS**, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **AM BANDIGAN CONSTRUCTION SERVICES, WAWOT BUILDERS, and TACLOBAN SOUTH PACIFIC CONSTRUCTION AND HARDWARE** for the “Supply, Delivery, Installation, Commissioning, and Testing of Cistern Tank, Water Pump and its Accessories, and Replacement of Sideport(SP)-21 Pressure Tank” thru Negotiated-Small Value Procurement with a total Approved Budget for the Contract (ABC) of **₱155,300.00**.

**WHEREAS**, the RFQs were duly acknowledged and received by the above suppliers;

**WHEREAS**, in response to the said request, only **AM BANDIGAN CONSTRUCTION SERVICES** has submitted its quotation within the deadline of bid submission;

**WHEREAS**, the quotation received was evaluated by the Committee on a “per lot” basis;

**WHEREAS**, upon careful examination of the quoted/bid, **AM BANDIGAN CONSTRUCTION SERVICES** was found to have offered the Single Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a.) To declare **AM BANDIGAN CONSTRUCTION SERVICES** as the bidder with the Single Calculated and Responsive Bid for the “Supply, Delivery, Installation, Commissioning, and Testing of Cistern Tank, Water Pump and its Accessories, and Replacement of Sideport(SP)-21 Pressure Tank” and Recommend award of contract to the said supplier with a total contract price of **₱154,572.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.
