- 3. ALL PRICES QUOTED REPEIN ARE VALID, BINDING AND EFFECTIVE AT LEAST WITHIN THIR PY GO/CADENDAR DAYS FROM DATE OF QUOTATION
- 2. AWARDEE shall be responsible for the source(s) of his supplies/materials/equipment and shall make deliveries in accordance with schedule, quality and specifications of the award and purchase reder (PO). Futher by the AWARDEE in comply with the same shall be ground for enrecllation of the award and purchase reder usued to that AWARDEE and for re-awarding the items(s) to the Next Lowest Responsive Proposal, as determined by the DBM Bids and Awards Committee and approved by the Secretary of Budget and Management or lustfully authorized representative.
- 3. The Goods shall only be delivered by the Supplier at the Property Section, General Services Division of the Procuring entity's Administrative Service located at Ground Floor, DBM Bidg. III., Gen. Solano St., San Stiguel, Manifa, not later than 1016 am up to 3:00 pm on the date of delivery as indicated in PO.

Marcover, the delivery schedule as indicated in the PO may be modified at the option of the Procuring Entity, with prior due notice, written or verbal, to the Sumplier,

- 4. Subject to the provisions of the preceding paragraph, where AWARDEE has accepted a purchase order but failed to deliver the required product(s) within the time culled for in the same order, he shall be extended a maximum period of fifteen (ES) calendar days to make good his delivery. Thereafter if AWARDEE has not completed delivery within the extended period, the subject pareliase order shall be cancelled and the award for the undelivered balance withdrawn from that AWARDEE, withing prejudice in the unposition of highlated damages. The DBM shall then purchase the required ments) from such other source(s) as it may determine, with the difference in price to be charged against the DEFAULTING AWARDEE. Refusal by the DEFAULTING AWARDEE to shoulder the price difference shall be ground for his disquilification from future hids of the same or all tierns, without prejudice to the imposition of other sourcitons as prescribed under R.A. 9184 and its IRR.
- 5. The Goods delivered are accepted by the Procuring Entity as to quantity only. However, inspection as to the Goods' compliance with the technical specifications, and its order and condition, will be dime in the presence of the representatives of bish Supplier and Procuring Entity within three (3) working days from the date of delivery upon prior due notice, written or weibal, in the authorize representative of the Supplier. The inspection will push through as scheduled even in the absence of the Supplier's representative, if the latter was duly norther. In which case, the results of the inspection conducted by the Procuring Entity shall be final and binding upon the Supplier.

Any defective neutral/products) that may be discovered by the DBM within seven (7) working days after acceptance of the same shall be replaced by the supplier within seven (7) working days or until stocks are available upon receipt of a written notice. Beyond the said time frame, defective units will be picked up by the supplier for assessment.
- 8. A penalty of our-tenth of one percent (0,001) of the cost of the imperformed portion for everyday of delay,

The maximum deduction shall be ten percent (18%) of the amount of contract. Once the cumulative amount of liquidated damages reaches ten percent (18%) of the amount of the contract, the procuring entity may reacted the contract, without prejudice to other courses of action and terredies open to 0. The Procuring Entity may also rescind the contract and impose 10% of the automat of the contract as inpulated damages, upon non-performance by the Supplier of any of its obligations under the contract.

The improvition of Inquidated damages in all instances shall be annuate, except upon prior regress for extension and approved thereof by the Procuring Emity before the scheduled adirectly date. Any request for extension not acted upon before delivery date shall be considered densed.
