Resolution No. 2025-11

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "Subscription to the Appian Platform for Business Process Management and Robotic Process Automation," with an Approved Budget for the Contract of P129,000,000.00 through the authorized appropriations under the FY 2025 General Appropriations Act (GAA) and Multi-Year Contractual Authority No. MYCA-BMB-C-24-0000093, as reflected in the Annual Procurement Plan, CY 2025;

WHEREAS, on January 28, 2025, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

WHEREAS, two (2) prospective bidders, namely: (i) Via Appia Philippines, Inc. (Via Appia); and (ii) Questronix Corporation (Questronix), attended the Pre-bid Conference on February 4, 2025;

WHEREAS, Supplemental/Bid Bulletin No. 1 was issued on February 11, 2025, to clarify, modify or amend items in the Bidding Documents;

WHEREAS, only one (1) bidder, the Joint Venture (JV) of Via Appia and Questronix, submitted a bid during the submission and opening of bids on February 18, 2025;

WHEREAS, after preliminary examination of the bid, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the submission of the JV of Via Appia and Questronix as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial component of the bid of the JV of Via Appia and Questronix, the DBM-BAC declared the submission of the JV of Via Appia and Questronix as the Single Calculated Bid in the amount of P128,602,560.00;

WHEREAS, after verification, validation, and ascertainment of all statements made and documents submitted by the JV of Via Appia and Questronix, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the same passed all the criteria for post-qualification;

WHEREAS, Section 36 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

NOW, THEREFORE, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of the Joint Venture of Via Appia Philippines, Inc. and Questronix Corporation for the Project, "Subscription to the Appian Platform for Business Process Management and Robotic Process Automation," in the amount of P128,602,560.00 as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 Revised IRR of RA No. 9184; and
- 2) To recommend to the DBM Head of the Procuring Entity that the contract for the Project be awarded to the Joint Venture of Via Appia Philippines, Inc. and Questronix Corporation in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR.

SUBSCRIPTION TO THE APPIAN PLATFORM FOR BUSINESS
PROCESS MANAGEMENT AND ROBOTIC PROCESS AUTOMATION

CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of MAY 15 2025 between the **DEPARTMENT OF BUDGET AND MANAGEMENT** of the Philippines (hereinafter called "the Entity") of the one part and the **JOINT VENTURE OF VIA APPIA PHILIPPINES, INC. AND QUESTRONIX CORPORATION** of Bonifacio Global City and Makati City, Philippines, respectively, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Subscription to the Appian Platform for Business Process Management and Robotic Process Automation, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Hundred Twenty-Eight Million Six Hundred Two Thousand Five Hundred Sixty Pesos (P128,602,560.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation**

Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of One Hundred Twenty-Eight Million Six Hundred Two Thousand Five Hundred Sixty Pesos (P128,602,560.00) or such other sums as may be ascertained, the **JOINT VENTURE OF VIA APPIA PHILIPPINES, INC. AND QUESTRONIX CORPORATION** agrees to deliver the Subscription to the Appian Platform for Business Process Management and Robotic Process Automation in accordance with its Bid.
4. The **DEPARTMENT OF BUDGET AND MANAGEMENT** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The period for the performance of the obligations under this Contract shall not go beyond the validity of the appropriation for this Project.
6. In compliance with item 4.3 of Appendix 33 of the 2016 Revised IRR of RA No. 9184 and consistent with Administrative Order No. 34, s. 2020 (Directing Strict Compliance By All Agencies and Instrumentalities of the Executive Department with Transparency, Accountability and Good Governance Policies and Measures in the Procurement Process), the DBM shall publish in its official website and social media platform the following post-award information:
 - (a) Project name;
 - (b) Approved budget for the contract;
 - (c) Contract period;
 - (d) Name of the winning bidder and its official business address;
 - (e) Amount of contract awarded;
 - (f) Date of award and acceptance; and
 - (g) Implementing office/unit/division/bureau of the concerned agency or instrumentality.
