BIDS AND AWARDS COMMITTEE

Resolution No. 2025-31

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "Cloud Infrastructure Subscription with Support and Maintenance for the Budget and Treasury Management System (BTMS)," with an Approved Budget for the Contract of P240,000,000.00 through the authorized appropriations under the FY 2025 General Appropriations Act (GAA) and Multi-Year Contractual Authority No. MYCA-BMB-C-24-0000102, as reflected in the Annual Procurement Plan, CY 2025;

WHEREAS, on February 18, 2025, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

WHEREAS, on March 18, 2025, after preliminary examination of the bids, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the submissions of (i) the Joint Venture of Radenta Technologies, Inc. and Sagesoft Solutions, Inc. (JV of Radenta and Sagesoft); (ii) the JV of Remax International, Inc. (Remax) and eCloudvalley Technology (Philippines), Inc. (eCloudvalley); and (iii) Novare Technologies, Inc. (Novare) as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

WHEREAS, after evaluation of the financial components of the bids, the bids were ranked based on the total calculated bid prices to identify the Lowest Calculated Bid, as follows:

1. JV of Radenta and Sagesoft	-	P189,999,999.99
2. JV of Remax and eCloudvalley	-	P214,995,000.00
3. Novare	-	P223,200,000.00

WHEREAS, the DBM-BAC accordingly declared the submission of the JV of Radenta and Sagesoft as the Lowest Calculated Bid in the amount of P189,999,999.99;

WHEREAS, based on the results of the post-qualification of the bid submission of the JV of Radenta and Sagesoft, the DBM-BAC issued DBM-BAC Resolution No. 2025-16 dated April 8, 2025, resolving as follows:

- 1) To declare the post-disqualification of the JV of Radenta and Sagesoft for the Project and to notify the said bidder in writing about its post-disqualification and the grounds for it, pursuant to Section 34.5 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184; and
- 2) To initiate and complete the post-qualification process on the bidder with the second Lowest Calculated Bid, the JV of Remax and eCloudvalley, pursuant to Section 34.6 of the same IRR;

WHEREAS, however, under DBM-BAC Resolution No. 2025-29 dated May 20, 2025, the DBM-BAC resolved, as follows:

- 1) To declare the post-disqualification of the JV of Remax and eCloudvalley for the Project, and to notify the said bidder in writing about its post-disqualification and the grounds for it, pursuant to Section 34.5 of the 2016 Revised IRR of RA No. 9184; and
- 2) To initiate and complete the post-qualification process on the bidder with the third Lowest Calculated Bid, Novare, pursuant to Section 34.7 of the same IRR;

WHEREAS, the DBM-BAC issued the Notice of Post-disqualification to the JV of Remax and eCloudvalley on May 22, 2025;¹

WHEREAS, Section 55.1 of the 2016 Revised IRR of RA No. 9184 provides, among others, that "[d]ecisions of the BAC at any stage of the procurement process may be questioned by **filing a request for reconsideration within the three (3) calendar days upon receipt of written notice** or upon verbal notification"; (emphasis supplied)

WHEREAS, through a letter dated May 26, 2025,² Remax sought reconsideration of the DBM-BAC's declaration of its submission as "post-disqualified." In support of its request for reconsideration, Remax presented the following arguments as grounds/bases to reconsider its post-disqualification and to reevaluate the same in its favor, to wit:

1. Remax fully acknowledged that the standard requirement mandates that submissions of its 2023 Income Tax Return and Quarterly VAT Returns be made via the Electronic Filing and Payment System (eFPS). However, Remax cited Bureau of Internal Revenue (BIR) Revenue Memorandum Circular No. 034-2025,³ which expressly provides an exception for cases where the enrollment in eFPS is still in process.

1. Enrollment in BIR-eFPS and eFPS-AAB is still in process[.]

2. To support its position, Remax enclosed a screenshot of eCloudvalley's eFPS enrollment status indicating that the application is "in progress – under investigation." Remax stated that the documentation reflects direct guidance received from BIR personnel.
3. Further, it was explained that the BIR does not issue a formal certificate for an eFPS enrollment in progress; instead, a screenshot of the enrollment status accompanied by an email confirmation—and a subsequent screenshot confirming "Record accepted"—is deemed sufficient proof.
4. Based on these clarifications and the supporting documentation provided, Remax asserted that eCloudvalley's filing via the eBIRForms facility falls within the permissible exception under BIR RMC No. 034-2025;

WHEREAS, the DBM-BAC noted that the Notice of Post-Disqualification dated May 21, 2025 was sent to the email address of Remax on May 22, 2025, and Remax's request for reconsideration was received by the DBM-BAC Secretariat via email on **May 26, 2025, which was one (1) day after the prescriptive period for filing a request for reconsideration (i.e., until May 25, 2025)**. The said request was subsequently denied by the DBM-BAC, pursuant to Section 55.1 of the 2016 Revised IRR of RA No. 9184, in relation to Clause 20 of Section II. Instructions to Bidders, as reiterated in Clause 20 of Section III. Bid Data Sheet of the Philippine Bidding Documents, and consistent with Section 34.2 of the 2016 Revised IRR of RA No. 9184, and the post-disqualification of the JV of Remax and eCloudvalley was affirmed;

WHEREAS, considering the foregoing and pursuant to DBM-BAC Resolution No. 2025-29, after verification, validation, and ascertainment of all statements made and documents submitted by Novare, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of Novare passed all the criteria for post-qualification.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To deny the request for reconsideration of the JV of Remax International, Inc. and eCloudvalley Technology (Philippines), Inc., and affirm its decision to declare the same as "post-disqualified";
- 2) To notify the JV of Remax International, Inc. and eCloudvalley Technology (Philippines), Inc. of its decision through the issuance of a response letter;
- 3) To declare the bid of Novare Technologies, Inc. for the Project, "Cloud Infrastructure Subscription with Support and Maintenance for the Budget and Treasury Management System (BTMS)," in the amount of P223,200,000.00, as the Lowest Calculated and Responsive Bid, in accordance with Section 34.4 of the 2016 Revised IRR of RA No. 9184;

- 4) To recommend to the DBM Head of the Procuring Entity that the contract for the Project be awarded to Novare Technologies, Inc. in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR; and
- 5) To notify all other bidders, in writing, of the DBM-BAC's recommendation within three (3) calendar days from the issuance of the resolution recommending award of the contract, pursuant to Section 37.1.1 of the same IRR.





CONTRACT AGREEMENT

THIS AGREEMENT made this _____ day of JUL 04 2025 20____ between the **DEPARTMENT OF BUDGET AND MANAGEMENT** of the Philippines (hereinafter called "the Entity") of the one part and **NOVARE TECHNOLOGIES, INC.** of Taguig City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Cloud Infrastructure Subscription with Support and Maintenance for the Budget and Treasury Management System (BTMS), and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Hundred Twenty-Three Million Two Hundred Thousand Pesos (P223,200,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the**

GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Two Hundred Twenty-Three Million Two Hundred Thousand Pesos (P223,200,000.00) or such other sums as may be ascertained, **NOVARE TECHNOLOGIES, INC.** agrees to deliver the Cloud Infrastructure Subscription with Support and Maintenance for the Budget and Treasury Management System (BTMS) in accordance with its Bid.
4. The **DEPARTMENT OF BUDGET AND MANAGEMENT** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The period for the performance of the obligations under this Contract shall not go beyond the validity of the appropriation for this Project.
6. In compliance with item 4.3 of Appendix 33 of the 2016 Revised IRR of RA No. 9184 and consistent with Administrative Order No. 34, s. 2020 (Directing Strict Compliance By All Agencies and Instrumentalities of the Executive Department with Transparency, Accountability and Good Governance Policies and Measures in the Procurement Process), the DBM shall publish in its official website and social media platform the following post-award information:
 - (a) Project name;
 - (b) Approved budget for the contract;
 - (c) Contract period;
 - (d) Name of the winning bidder and its official business address;
 - (e) Amount of contract awarded;
 - (f) Date of award and acceptance; and
 - (g) Implementing office/unit/division/bureau of the concerned agency or instrumentality.
