**BAC Resolution Declaring Lowest Calculated and Responsive Bid,
and Recommending Award of Contract for the
“Lease of Venue with Catering Services and provision of LED Wall for the conduct of
Budget Forum for FY 2026 Budget Preparation on February 10, 2025”**

RESOLUTION No. 2025-01-005

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to four (4) bonafide local suppliers namely: **MADISSON PARK HOTEL INC., IRONWOOD HOTEL, THE TROPICS OF MCARTHUR, AND COZZY AISIA LIFESTYLE INC.** for the “Lease of Venue with Catering Services and provision of LED Wall for the conduct of Budget Forum for FY 2026 Budget Preparation on February 10, 2025” thru Negotiated-Lease of Real Property and Venue with a total Approved Budget for the Contract (ABC) of **₱356,950.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above-mentioned suppliers;

WHEREAS, in response to the said request, **MADISSON PARK HOTEL INC., IRONWOOD HOTEL, AND COZZY AISIA LIFESTYLE INC.** submitted their quotation within the deadline of bid submission; while **THE TROPICS OF MCARTHUR** only acknowledged receipt of the RFQ but did not submit a quotation;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis with a passing rate of 90%. The responsive bidder were evaluated using the criteria on Table D – Table of Rating Factors for Lease of Venue, pages 184-185, Annex H of the 2016 Revised IRR of RA 9184, with emphasis on (a) Availability, (b) Location & Site Condition, (c) Neighborhood Data, and (4) Venue, wherein **MADISSON PARK HOTEL INC.** obtained a ‘Passed’ rating of **97.81%** whereas **IRONWOOD HOTEL** gained a ‘Failed’ rating of **88.80%**;


WHEREAS, upon careful examination of the quoted/bid, **MADISSON PARK HOTEL INC.** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a.) To declare **MADISSON PARK HOTEL INC.** as the bidder with the Lowest Calculated and Responsive Bid for the “Lease of Venue with Catering Services and provision of LED Wall for the conduct of Budget Forum for FY 2026 Budget Preparation on February 10, 2025” and Recommend award of contract to the said supplier with a total contract price of **₱356,950.00**;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and

- c.) To recommend for approval by the **REGIONAL DIRECTOR** of the **DEPARTMENT OF BUDGET AND MANAGEMENT ROVIII** the foregoing findings and recommendation.


