## BAC Resolution Declaring Lowest Calculated and Responsive Bid, and Recommending Award of Contract for the "Supply, Delivery and Installation of DBM Signage Panel"

## RESOLUTION No. 2025-02-008

WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to four (4) bonafide local suppliers namely: LADERA ARTSPOT, BAI PRINTS HUB, HEAVENS SIGNCRAFT and AEP SIGNSHOP for the "Supply, Delivery and Installation of DBM Signage Panel" thru Negotiated-Small Value Procurement with a total Approved Budget for the Contract (ABC) of ₱22,700.00.

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, two (2) suppliers namely LADERA ARTSPOT and BAI PRINTS HUB submitted their quotation within the deadline of bid submission; while HEAVENS SIGNCRAFT and AEP SIGNSHOP only acknowledged receipt but did not submit quotation;

WHEREAS, the quotations received were evaluated by the Committee on a "per lot" basis;

WHEREAS, upon careful examination of the quoted/bid, BAI PRINTS HUB was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

**NOW, THEREFORE,** We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To declare BAI PRINTS HUB as the bidder with the Lowest Calculated and Responsive Bid for the "Supply, Delivery and Installation of DBM Signage Panel" and Recommend award of contract to the said supplier with a total contract price of ₱19,200.00;
- b.) To specify in the Notice of Award (NOA) that processing of payment shall be subject to compliance with the required documentary requirements provided in the procurement terms and conditions of the RFQ; and
- c.) To recommend for approval by the <u>REGIONAL DIRECTOR</u> of the <u>DEPARTMENT</u> <u>OF BUDGET AND MANAGEMENT ROVIII</u> the foregoing findings and recommendation.
