




3. The service provider must be in the business for at least two (2) years and should have a physical store within Tacloban city or its neighboring municipality for faster transaction. The accomplishment of the attached template 'List of Completed and On-going Contracts' as proof of operation in the last two (2) years shall be attached upon submission of RFQ			
4. The Inspection Committee shall be present during each scheduled treatment and shall likewise conduct inspections at any time necessary. This shall be done by random checking of service rendered viz-a-viz Work Plan (e.g. control methods, materials, tools, & equipment). Any adverse findings shall be a ground for termination of contract at the option of the PE.
