WHEREAS, the Department of Budget and Management ROVIII-BAC issued Request for Quotation (RFQ) to three (3) bonafide local suppliers namely: **MAPECON TACLOBAN INCORPORATED, SIGMA PEST CONTROL SERVICES, and BIOFREE PEST CONTROL SERVICES-TACLOBAN** for the “**Delivery of General Termite Control at DBM Regional Office Main and Multi-Purpose Building**” thru **Small Value Procurement** per R.A. 12009 with a total **Approved Budget for the Contract (ABC)** of **₱156,000.00**.

WHEREAS, the RFQs were duly acknowledged and received by the above suppliers;

WHEREAS, in response to the said request, all suppliers have submitted its quotations within the deadline of bid submission;

WHEREAS, the quotations received were evaluated by the Committee on a “per lot” basis;

WHEREAS, upon careful examination of the quoted/bid, **MAPECON TACLOBAN INCORPORATED** was found to have offered the Lowest Calculated and Responsive Bid, as indicated in the attached Abstract of Quotation;

WHEREAS, the Bids and Awards Committee thru the Secretariat and the end-user further verified on the performance delivery of the said supplier thru phone calls to various government and private offices cited in the submitted “List of Completed and On-going Contracts” and these offices generally provided positive feedbacks/comments;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


