**Resolution No. 2025-39**

**WHEREAS**, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Public Bidding for the Project, "Supply and Delivery of Smart Televisions," with an Approved Budget for the Contract of P2,176,000.00 through the Continuing Appropriations, FY 2024 General Appropriations Act, as reflected in the Supplemental Annual Procurement Plan No. 3, CY 2025;

**WHEREAS**, on May 13, 2025, the Invitation to Bid for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

**WHEREAS**, seven (7) prospective bidders, namely: (i) The Brain Computer Corporation; (ii) Avid Sales Corporation; (iii) Compart's Computer Sales; (iv) M&G Non Specialized Wholesale Trading; (v) Xitrix Computer Corporation (Xitrix); (vi) St. Christ International Trading Corporation; and (vii) Silvanus Non-Specialized Wholesale Trading, attended the Pre-bid Conference on May 20, 2025;

**WHEREAS**, Supplemental/Bid Bulletin No. 1 was issued on May 27, 2025 to clarify, modify or amend items in the Bidding Documents;

**WHEREAS**, only one (1) bidder, Xitrix, submitted a bid during the submission and opening of bids on June 3, 2025;

**WHEREAS**, after preliminary examination of the bid, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the submission of Xitrix as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents;

**WHEREAS**, after evaluation of the financial component of the bid of Xitrix, the DBM-BAC declared the submission of Xitrix as the Single Calculated Bid in the amount of P1,212,800.00;

**WHEREAS**, after verification, validation, and ascertainment of all statements made and documents submitted by Xitrix, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of Xitrix passed all the criteria for post-qualification;

**WHEREAS**, Section 36 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder submits a bid, and its bid is found to be responsive to the bidding requirements.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

- 1) To declare the bid of Xitrix Computer Corporation for the Project, "Supply and Delivery of Smart Televisions," in the amount of P1,212,800.00 as the Single Calculated and Responsive Bid, in accordance with Section 34.4 in relation to Section 36 of the 2016 Revised IRR of RA No. 9184; and
- 2) To recommend to the DBM Head of the Procuring Entity that the contract for the Project be awarded to Xitrix Computer Corporation in the above-mentioned amount, in accordance with Section 37.1.1 of the same IRR.

Dear **Mr. Libao**:

Pursuant to Section 37.2.1 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 and as provided in the Notice of Award (NOA) which you received on July 18, 2025, you have ten (10) calendar days from receipt of the NOA to post the required performance security and enter into a contract with the Department of Budget and Management (DBM).
