Clarification:

Whether in a corporation, the authorized representative can authorize another individual/representative to initial the documents?

The Secretary's Certificate should establish all authorized representative/s and the authority being given to the representative/s. Moreover, all powers being extended to the representative should be clearly stated including the power of the representative to authorize the another individual/representative to initial the documents on his/her behalf.

If this is not established through the Secretary's Certificate An authorization letter from the authorized representative is not enough basis.



Other matters:

- > For authentication purposes, all pages of the bid should be initialed by the authorized signatory.
- > The "No Contact Rule" shall be strictly observed. Bidders are not allowed to call or talk to any member of the Bids and Awards Committee, Technical Working Group or Secretariat effective December 22, 2016 right after the opening of bids.
- > For guidance and information of all concerned.
