Questions from a bidder (MULTI-FOLD LINKS, INC.) -

- 1. Kindly provide us with the complete list/inventory of Data Center components covered by this maintenance project stating the current condition of the equipment (e.g. working, not working, end of life) and years in operations, and last maintenance activity conducted on the equipment.
- 2. Kindly specify if DBM will shoulder the parts 2. replacement or defective component (e.g. fire suppression components) if reported defective or are found to be no longer operational/functional.
- 3. Technical Specification page 63, item 7.4; 3. In replace batteries as necessary, and fine-tune each opening.

Who will shoulder the replacement for UPS battery? Kindly identify the specification of the battery. Will DBM allow compatible or equivalent brand of battery as replacement?

- Technical Specification page 59, item 2.1.19;
 kindly specify what brand of CCTV and video analytics management software DBM is currently using,
- 5. What document/s do you require as a proof for 5. the Licensed Engineers registered as STE?

- 1. Please refer to Section VI. Schedule of Requirements on pp. 54-55 of the Bidding Documents, item 3, for the list of Data Center Equipment and Components. The Data Center Equipment and Components are all in working condition and the last maintenance was conducted in the 3rd quarter of 2016.
- All replacements indicated in Section VII.
 Technical Specifications are for the account of the Contractor. Only equipment/materials listed on page 64, item 2(11) shall be shouldered by DBM.
- In reference to Section VII. Technical Specifications on p. 64, only equipment listed in item 2(11) shall be shouldered by DBM; replacement of UPS batteries is part of the Contractor's services and corresponding cost shall not be shouldered by DBM.

For battery specification, the bidder may conduct an ocular inspection.

For battery replacement, the end-user prefers an equivalent or better brand of battery.

- The DBM Data Center is currently using J&S IP camera and Mainpro video software.
- The required proof for the licensed Engineers registered as STE are, as follows:
 - a) Copy of Professional License issued by the Professional Regulation Commission and training certificates on relevant academic discipline to the classification of intended assignment.
 - b) Certification that the engineer is a full-time employee and among the technical personnel, and whose training and experience shall be considered appropriate to the classification(s) and/or category of intended assignment, and the Project may be sustained by such qualifications.

1. Can we request for equipment details such as brand, vendor, date purchased, EUL, copy of PM reports since purchased, warranty, capacity utilization and expiration of support?

- 3. What is the tier level of the data center (TIA 942.1, 2 or 3?)
- 4. Where is the location of the data center?
- 5. What are the features required for information management system?
- 6. Are the upgrade and replacement of the specified equipment, if identified necessary, included in the ABC such as biometrics, CCTV, fire suppression, PACU, UPS and water leak detection system?

- Can we request for details and a network diagram on the network connectivity and structured cabling of the data center.
- 8. Is there a hot aisle / cold aisle setup or containment?
- 9. What is the name plate rating of racks?
- 10. Is each rack on a single phase or a 3-phase basis?
- 11. Can we request for the data center layout or map?

The list includes the brand name and serial number of the Data Center Equipment and Components. - 3. The bidder may conduct an ocular inspection to verify this inquiry.
- 4. The Data Center is located at the ICTSS, 3rd floor, DBM Bldg II, Gen. Solano St., San Miguel, Manila.
- 5. The Project requires Integrated Monitoring System for Data Center Equipment and Components, and not Information Management System.
- 6. All upgrades and replacements indicated in Section VI. Schedule of Requirements and Section VII. Technical Specifications are for the account of the Contractor. Only equipment/materials listed on page 64 of the Bidding Documents; item 2(11) shall be shouldered by DBM.
- 7. These information are confidential and can only be disclosed to the winning bidder.
- 8. The bidder may conduct an ocular inspection to verify this inquiry.
