If more is needed, will there be a variation order? 2. Can we submit COSH Seminar Certificate of our engineer instead of Fire Safety Certificate? 	<ol style="list-style-type: none"> 1. The quantities indicated in the Bill of Quantities are the estimated quantities for the works. They should not, therefore, be taken as the actual and correct quantities of the works to be executed by the Contractor in fulfillment of its obligations under the contract. The quantities can vary up to ten percent (10%) of the contract price to account for variation orders in accordance to Annex “E” of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184. 2. No. The Registered Civil Engineer for the Project should have completed a course on Fire Safety Measures; and the Bid should include the corresponding Training Certificate of the Engineer.

- The “No Contact Rule” shall be strictly observed. Bidders are not allowed to communicate with any member of the Bids and Awards Committee, Technical Working Group or Secretariat effective September 13, 2022 right after the opening of bids.
