- c. The similar contract for this Project shall refer to the printing and delivery of any bound printed material containing colored texts or graphics and not less than one hundred (100) pages. If the printing and delivery of any bound printed materials containing colored texts or graphics and not less than one hundred (100) pages form part of a bigger contract, only the cost component of the printing and delivery of any bound printed material containing colored texts or graphics and not less than one hundred (100) pages shall be considered for purposes of comparing the value thereof to at least fifty percent (50%) of the ABC.
