BIDS AND AWARDS COMMITTEE

Resolution No. 2025-23

WHEREAS, the Department of Budget and Management-Bids and Awards Committee (DBM-BAC) conducted a Negotiated Procurement under Two Failed Biddings modality for the Project, "CISCO Equipment Licenses and Support Services Subscription," with an Approved Budget for the Contract of P28,720,000.00 through the authorized appropriations under the FY 2025 General Appropriations Act (GAA), as reflected in the Supplemental Annual Procurement Plan No. 3, CY 2025;

WHEREAS, on March 18, 2025, the Invitation for Negotiated Procurement for the Project was posted on the Philippine Government Electronic Procurement System (PhilGEPS) website, the DBM website, the official DBM Facebook page, and all DBM bulletin boards;

WHEREAS, the DBM-BAC invited at least three (3) suppliers, including those disqualified in previous biddings for the project, for negotiations to ensure effective competition;

WHEREAS, a meeting with all interested bidders was held on March 25, 2025, wherein four (4) interested bidders, namely: (i) Macrologic Diversified Technologies, Inc. (Macrologic); (ii) Mustard Seed Systems Corporation; (iii) Trends and Technologies, Inc. (Trends); and (iv) Exakt IT Services, Inc., attended;

WHEREAS, during the submission and opening of the Eligibility Documents, Technical Proposals, and Best and Final Offers on April 8, 2025, two (2) bidders submitted their quotations, namely: (i) Trends; and (ii) the Joint Venture (JV) of Accent Micro Technologies, Inc. (AMTI) and Macrologic;

WHEREAS, after preliminary examination of the quotations, the DBM-BAC, using non-discretionary "pass/fail" criteria, determined the following:

- 1) The submission of the JV of AMTI and Macrologic as "passed" for complying with all the eligibility and technical requirements as stated in the Bidding Documents; and
- The submission of Trends as "failed" for Trends' failure to comply with the documents required to be submitted for the technical requirements, as prescribed under Section 23.1.a of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;

WHEREAS, Section 30.1 of the 2016 Revised IRR of RA No. 9184 partly provides that "bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as 'failed'";

WHEREAS, after evaluation of the financial component of the quotation of the JV of AMTI and Macrologic, the DBM-BAC declared the submission of the JV of AMTI and Macrologic as the Single Calculated Quotation in the amount of P26,836,924.80;

WHEREAS, after verification, validation, and ascertainment of all statements made and documents submitted by the JV of AMTI and Macrologic, using non-discretionary criteria, as stated in the Bidding Documents, it was determined that the submission of the JV of AMTI and Macrologic passed all the criteria for post-qualification;

WHEREAS, Section 36 of the 2016 Revised IRR of RA No. 9184 provides, among others, that a single calculated and responsive bid shall be considered for award if only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;

WHEREAS, Sections V.D.1(b.v) of Annex "H" of the 2016 Revised IRR of RA No. 9184 provides, among others, that the BAC shall recommend award of contract to the HOPE in favor of the supplier, contractor or consultant determined to have the Single or Lowest Calculated and Responsive Quotation (for goods and infrastructure projects) in accordance with Section IV(L) of the same Annex;

NOW, THEREFORE, for and in consideration of the foregoing premises, the DBM-BAC **RESOLVED**, as it is hereby **RESOLVED**, the following:

1) To declare the quotation of the Joint Venture of Accent Micro Technologies, Inc. and Macrologic Diversified Technologies, Inc. for the Project, "CISCO Equipment Licenses and Support Services Subscription," in the amount of P26,836,924.80 as the Single Calculated and Responsive Quotation, in accordance with Sections V.D.1(b.v) and IV(L) of Annex "H" of the 2016 Revised IRR of RA No. 9184; and

2) To recommend to the DBM Head of the Procuring Entity that the contract for the Project be awarded to the Joint Venture of Accent Micro Technologies, Inc. and Macrologic Diversified Technologies, Inc. in the above-mentioned amount, in accordance with Sections 37 and IV(L) of Annex "H" of the same IRR.

CONTRACT No. 2025-24 CISCO EQUIPMENT LICENSES AND SUPPORT SERVICES SUBSCRIPTION

CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of <u>JUN 2 3 2025</u> 20___ between the **DEPARTMENT OF BUDGET AND MANAGEMENT** of the Philippines (hereinafter called "the Entity") of the one part and the **JOINT VENTURE OF ACCENT MICRO TECHNOLOGIES, INC. AND MACROLOGIC DIVERSIFIED TECHNOLOGIES, INC.** of Pasig City and Bacoor City, Philippines, respectively, (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly CISCO Equipment Licenses and Support Services Subscription, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Twenty-Six Million Eight Hundred Thirty-Six Thousand Nine Hundred Twenty-Four Pesos & 80/100 (P26,836,924.80) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation

Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of Twenty-Six Million Eight Hundred Thirty-Six Thousand Nine Hundred Twenty-Four Pesos & 80/100 (P26,836,924.80) or such other sums as may be ascertained, the JOINT VENTURE OF ACCENT MICRO TECHNOLOGIES, INC. AND MACROLOGIC DIVERSIFIED TECHNOLOGIES, INC. agrees to deliver the CISCO Equipment Licenses and Support Services Subscription in accordance with its Bid.
- 4. The **DEPARTMENT OF BUDGET AND MANAGEMENT** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. The period for the performance of the obligations under this Contract shall not go beyond the validity of the appropriation for this Project.
- 6. In compliance with item 4.3 of Appendix 33 of the 2016 Revised IRR of RA No. 9184 and consistent with Administrative Order No. 34, s. 2020 (Directing Strict Compliance By All Agencies and Instrumentalities of the Executive Department with Transparency, Accountability and Good Governance Policies and Measures in the Procurement Process), the DBM shall publish in its official website and social media platform the following post-award information:
 - (a) Project name;
 - (b) Approved budget for the contract;
 - (c) Contract period;
 - (d) Name of the winning bidder and its official business address;
 - (e) Amount of contract awarded;
 - (f) Date of award and acceptance; and
 - (g) Implementing office/unit/division/bureau of the concerned agency or instrumentality.
