
# 2023 NATIONAL GOVERNMENT DISBURSEMENT REPORT

3<sup>rd</sup> QUARTER

July to September 2023

n the third quarter of 2023, spending saw a significant boost, with a growth of Php 141.0 billion (11.1%) compared to the same period in 2022. Actual disbursements exceeded the program by Php 129.6 billion (10.1%), indicating improved spending by various agencies.

NG Fiscal Performance for January to September, 2022 and 2023 (in billion Pesos)

Due to better revenue and disbursement performance, the NG fiscal deficit improved by 2.9% to Php 983.5 billion in the first three quarters of 2023 from Php 1.01 trillion during the same period in 2022.
