Special Provisions

1. *Use of the Fund.* The amount herein appropriated shall be used to cover the employer's share of premiums of employees whose salaries are charged to the General Fund. Special Funds or Special Accounts in the General Fund shall bear the employer's share in cases where employee salaries are charged to said funds.

2. *Administration of the Fund.* The amount herein authorized to cover the contribution of the National Government shall be under the administration of the Office of Budget and Management.

D. Retirement Gratuity Fund

Special Provision

1. *Use of the Fund.* The amount herein appropriated shall be used for payment of pensions, retirement gratuity and separation pay of national government officials and employees, including military personnel, members of the Batasang Pambansa who are entitled thereto, and for the adjustment of retirement gratuities of municipal judges who retired before the implementation but after the enactment of Republic Act No. 6031, subject to proper Budget Execution Guidelines to be issued by the Office of Budget and Management.

E. Salary Adjustment Fund

No. 985 and in accordance with an implementing Budget Circular that may be issued by the Office of Budget and Management and for merit increases in accordance with the provisions of Letter of Instructions No. 1019 and the implementing Joint CSC-OBM Memorandum Circular.

F. Terminal Leave Benefits Fund

1.0 *Terminal Leave Benefits Fund.* For payment of terminal leave benefits to officials and employees entitled thereto ₱ 77,210,000

Special Provision

1. *Use of the Fund.* The appropriations authorized herein shall be used for payment of the terminal leaves of officials and employees

whose salaries are charged against the General Fund of the National Government. The terminal leaves of those officials and employees who are receiving salaries from special accounts or special funds shall be charged against the corresponding funds from which their salaries are charged, and in no case shall such leaves be paid against this Fund.

The payment of terminal leave benefits from this fund shall be made in accordance with law and budget rules and regulations.

G. Barangay Officials Insurance Premium Fund
