Special Provision(s)

- 1. Integrated Protected Areas Fund. In addition to the amounts appropriated herein, the following funding sources, constituted into the Integrated Protected Areas Fund (IPAF) shall be used to finance projects and activities of the Mational Integrated Protected Areas System (NIPAS) in accordance with Section 16 of R.A. Mo. 7586, as amended by R.A. Mo. 10629:
- a) Thirty Million Pesos (P30,000,000) from the Twenty-Five percent (25%) income generated by each protected area from the operations of the MIPAS and management of wild flora and fauna, deposited with the Mational Treasury and released subject to the submission of a Special Budget pursuant to Section 35, Chapter 5, Book VI of E.O. 292, s. 1987; and
- b) Seventy-Five percent (75%) income retained by each Protected Area Management Board (PAMB), deposited in an authorized government depository bank.

In no case shall the amount be used for payment for Personnel Services.

The DEMR and each PAMB shall submit to the DBM, the House Committee on Appropriations and the Senate Committee on Finance, either in printed form or by the way of electronic document, quarterly reports on the financial and physical accomplishments, including the list of projects and activities and their corresponding amounts. The Secretary of Environment and Matural Resources and the Agency's web administrator or his/her equivalent shall be responsible for ensuring that said quarterly reports are likewise posted on the DEMR website.

2. Wildlife Management Fund. In addition to the amounts appropriated herein, the amount of Five Million Five Hundred Thousand Pesos (P5,500,000) shall be used for the conservation and protection of mildlife resources sourced from fines, damages, fees, charges, donations, endowments, grants or contributions collected or granted within the jurisdiction of the DEMR, constituted into the Mildlife Management Fund in accordance with Section 4 of R.A. No. 9147.

Release of funds shall be subject to the submission of a Special Budget pursuant to Section 35, Chapter 5, Book VI of E.O. No.

The DEMR shall submit to the DBM, the House Committee on Appropriations and the Senate Committee on Finance, either in printed form or by the way of electronic document, quarterly reports on financial and physical accomplishments, including the list of projects and activities and their corresponding amounts. The Secretary of Environment and Matural Resources and the Agency's web administrator or his/her equivalent shall be responsible for ensuring that said quarterly reports are posted in the DEMR website.

- 3. Comprehensive Agrarian Reform Program. The amounts of One Hundred Two Million Three Hundred Forty-Two Thousand Pesos (P102,342,000) and One Hundred Fifty Million Pesos (P150,000,000) appropriated herein shall be used exclusively in support of the Land Acquisition and Distribution and Program Beneficiaries Development, respectively, under the Comprehensive Agrarian Reform Program.
- 4. National Greening Program. The amount of Three Billion Five Hundred Six Million Six Hundred Forty Five Thousand Pesos (P3,506,645,000) appropriated herein for the Forest Development, Rehabilitation and Protection shall be used for the following Mational Greening Program purposes with their coresponding amounts:
- a) P3,263,959,000 for site maintenance and protection covering prior years' planting activities and site preparation and mobilization for the current year's planting activities. Release of funds shall be subject to the submission to the DBM, either in printed form or electronic document, of a report on the status of accomplishment of the FY 2015 planting activities as of September 30 2015, including geo-tagged photos taken at a spatial resolution of 2-4 cm per pixel with time stamp; and
- b) P242,686,000 for seedling or planting activities and site maintenance and protection covering current year's planting activities. Release of funds shall be subject to the submission to the DBM, either in printed form or electronic document, of the FY 2016 identified sites for target planting activities, including geo-tagged photos taken at a spatial resolution of 2-4 cm per pixel with time stamp.

In the selection of planting sites, the DEMR shall give priority to communities ravaged by extreme meather events such as, but not limited to, typhoons Yolanda and Lando and the prolonged El Miño. The planting materials shall be responsive to the needs of the said communities.

Planting materials should also include fruit bearing trees, sap bearing trees, rubber trees, bamboo and palm oil trees subject to the result of the survey, mapping and planning activities for the suitability of the area to the said planting materials.

In the implementation of the MGP, the DEWR must earmark an amount for State Universities and Colleges to be used for nurseries including clonal nurseries, mangrove reforestation and forest research.

The Secretary of Environment and Matural Resources and the Agency's web administrator or his/her equivalent shall be responsible for ensuring that the status of accomplishment of the MGP from 2011 to 2016, including the geo-tagged photos, and the impact of the program to the communities are posted on the DEMR and MGP websites.

5. National Greening Program (NGP) Modification. The Secretary of Environment and Natural Resources is authorized to modify the allotment released for the NGP due to declaration of natural or man-made calamity and/or force majeure which will adversely affect the survival of the seedlings to be planted: PROVIDED, That the modification shall be made within the Region: PROVIDED, FURTHER, That the same may only be undertaken once: PROVIDED, FURTHERMORE, That the allotment released has not been obligated.

The DEWR shall inform the DBM, in writing, of the modification as well as the corresponding targets within five (5) calendar days upon the approval of the DEWR Secretary.

The DEWR shall submit to the DBM, the House Committee on Appropriations and the Senate Committee on Finance, reports on financial and physical accomplishments on the utilization and modification of the said amount including the list of projects.

The Secretary of Environment and Matural Resources and the Agency's web administrator or his/her equivalent shall be responsible for ensuring that such utilization and modification are posted on the official website of the DEWR which shall be considered compliance with the said reportorial requirement.

Failure to comply with any of the foregoing shall result in the automatic suspension of the salaries of the responsible official and/or employee until they have complied with the above requirements pursuant to Section 57, Chapter 6, Book VI of E.O. Mo. 292. Repeated failure or refusal of said official or employee to submit the above reports without any justifiable cause may be a ground for administrative disciplinary action, subject to pertinent civil service rules and regulations. The head of agency shall be responsible for ensuring compliance with this penalty provision.

6. Bottom-up Budgeting Projects. The amount appropriated herein for the Mational Greening Program includes One Hundred Fifty Mine Million Two Hundred Minety Three Thousand Pesos (P159,293,000) which shall be used for the Bottom-Up Budgeting (BuB) Projects. LGUs that will implement BuB Projects shall be limited to those that have complied with the requirements of Good Financial Mousekeeping under the Seal of Good Local Governance and LGU Public Financial Management Improvement Program pursuant to DBM-DILG-DSMD-MAPC JMC. No. 5 dated October 1, 2014 and such other criteria as may be provided in the guidelines.

The DEMR shall submit to the DBM, the House Committee on Appropriations and the Senate Committee on Finance, either in printed form or by way of electronic document, quarterly reports on the financial and physical accomplishments of BuB Projects. The Secretary of Environment and Natural Resources and the Agency's web administrator or his/her equivalent shall be responsible for ensuring that said reports are likewise posted through the OpenBuB Portal.

PROGRAMS

- 7. Establishment of Arboretum. The Biodiversity Management Bureau (BMB) of the DEWR shall establish an Arboretum of native endemic and indigenous tree and plant species at the Minoy Aquino Parks and Wildlife Center.
- 8. Operational Plan for the Manila Bay Coastal Management Strategy. Of the amounts appropriated herein, Eighty Million Pesos (P80,000,000) shall be used for the implementation of the Operational Plan for the Manila Bay Coastal Management Strategy pursuant to the Supreme Court Decision in Metropolitan Manila Development Authority, et al., vs. Concerned Citizens of Manila Bay, G.R. Mo. 171947-48 promulgated on December 18, 2008.

Release of said funds shall be subject to the submission by the DEMR to the DBM of its detailed program of work.

9. Appropriations for Programs and Specific Activities. The amounts appropriated herein for the programs of the agency shall be used specifically for the following activities in the indicated amounts and conditions:
