Special Provision(s)

1. **Pambansang Pabahay Para sa Pilipino Program.** The amount of Seven Hundred Fifty Million Eight Hundred Fourteen Thousand Pesos (P750,814,000) appropriated herein under Pambansang Pabahay Para sa Pilipino (4PH) Program shall be used for the interest support subsidy for the 4PH Program and other financial assistance or subsidy to further improve the affordability of the 4PH housing packages: *Provided*, That not less than seventy percent (70%) of the total amount shall be used for the interest support subsidy: *Provided, further*, That the balance may be used for the following financial assistance or subsidy for households belonging to the bottom thirty percent (30%) income decile:

- (a) Mortgage redemption insurance, fire insurance and other property related insurance of up to Five Hundred Pesos (P500) per month per household beneficiary;
- (b) Estate management subsidy, estimated to be around Twenty Five Pesos (P25) per square meter (sqm) per month; and
- (c) Time-limited rental subsidies for families whose borrowing capacity are assessed by Pag-IBIG fund to be insufficient for the socialized housing units under 4PH: *Provided*, That the households availing the rental subsidy meet the following criteria: (a) they are in need of temporary accommodations while awaiting their relocation/resettlement to the 4PH housing units and (b) they do not have access to any similar rental assistance program of the government.

This provision is subject to the guidelines to be issued by the Department of Human Settlements and Urban Development (DHSUD), in coordination with the National Economic and Development Authority (NEDA).

**2. Development of Subsidy Policy for the 4PH Program.** The DHSUD, in coordination with the NEDA, shall formulate a subsidy policy for the 4PH Program, which will be implemented beginning 2024. The policy will ensure that poor households receive higher subsidies than non-poor households, and that the majority of beneficiaries will come from the informal settlements, the poorer half of Filipino households, and households headed by minimum wage earners. The DHSUD shall be responsible for monitoring the compliance of local government units (LGUs) and other partners of the 4PH Program to this subsidy policy.

**3. Reporting and Posting Requirements.** The DHSUD shall submit quarterly reports on its financial and physical accomplishments, within thirty (30) days after the end of every quarter, through the following:

- (a) Unified Reporting System (URS) or other electronic means for reports not covered by the URS; and
- (b) DHSUD's website.

The DHSUD shall send written notice when said reports have been submitted or posted on its website to the DBM, House of Representatives, Senate of the Philippines, House Committee on Appropriations, Senate Committee on Finance, and other offices where the submission of reports is required under existing laws, rules and regulations. The date of notice to said agencies shall be considered the date of compliance with this requirement.
