## CORPORATE BUDGET CIRCULAR

No. 21  
June 15, 2011

**TO :** The Chairman, Local Water Utilities Administration; All Governing Boards of Local Water Districts; and Other Officials Concerned

**SUBJECT :** Amendatory Guidelines on the Implementation of the Revised Rates of Representation and Transportation Allowances (RATA) of Officials in Local Water Districts (LWDs)

### 1.0 Purpose

This Circular is issued to implement the revised equivalent ranks of certain LWD officials to national government officials entitled to RATA in accordance with the hierarchy of positions in LWDs.

### 2.0 Equivalent Ranks

For purpose of determining the maximum monthly RATA rates for LWD officials, the latter are equated to national government officials entitled to RATA under the pertinent general provision in the annual General Appropriations Act. Their modified equivalent ranks to national government officials are as shown in Annex "A."

### 3.0 Conditional Requirements

The implementation of the revised rates of RATA should take into consideration the financial strength and stability of LWDs. Thus, only LWDs which have positive balance in average net income in the prior twelve months operation are allowed to implement the revised RATA rates. On the other hand, LWDs which are losing or on breakeven operations shall not be allowed to implement said revised rates.

**4.0 Fund Source**

The additional funding requirement for RATA for the LWD officials concerned shall be charged against the respective approved corporate operating budgets of LWDs.

**5.0 Amendatory Clause**

This Circular amends "Annex A" of Corporate Budget Circular No. 18 dated November 14, 2000.

**6.0 Effectivity**

This Circular shall take effect January 1, 2011.
