SUBJECT : Implementation of the Department of Budget and Management's Revised Organizational Structure

- 1.0 The Department of Budget and Management (DBM) has implemented and adopted a revised organizational set-up to make its organization more responsive to the thrusts of the new Administration, and more effective and efficient in the implementation of various public expenditure management (PEM) and public financial management reform initiatives in government.
