



**DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 6-A**

**SUBJECT : AMENDMENTS TO DBM-DILG-DSWD-NAPC JMC NO. 6: POLICY GUIDELINES AND PROCEDURES IN THE IMPLEMENTATION OF THE BOTTOM-UP BUDGETING PROJECTS FOR FY2015**

- 
1. The DBM-DILG-DSWD-NAPC JMC No. 6, titled "Policy Guidelines and Procedures in the Implementation of the Bottom-up Budgeting Projects for FY2015 ", was issued to prescribe the policies and procedures for the implementation of Bottom-up Budgeting projects in FY2015.
  2. This JMC is being issued to amend sections of JMC No. 6 to extend the period for which LGUs must comply with the good governance conditions of the BuB Program.
  3. Section 4.3.1 and 4.3.2 are hereby amended as follows:

"4.3.1 LGUs will be given until the third quarter of 2016 to comply with the BuB governance conditions set in Section 4.12. LGUs shall coordinate with the concerned DILG or DBM regional offices for this.

4.3.2 If a city or municipality fails to comply with these governance conditions, NGAs shall release funds to the provincial government where the city or municipality is a part of, for the implementation of identified BuB projects, subject to the following conditions:

- The provincial government has complied with the Good Financial Housekeeping conditions
- The provincial government submits to the concerned BuB participating agency a letter indicating its willingness to implement BuB projects in the specified LGUs that have not complied with the prescribed governance conditions, and other documents that may be required by the

participating agency. For BuB-LGSF projects, the letter shall be submitted to the DILG (BuB-PMO), which shall then in turn make the funds release request to DBM.

- The NGA must inform the LPRAT if a BuB project is to be implemented by the provincial government. However, the LPRAT's consent for provincial government implementation is no longer necessary."

4. Section 4.5.9 is hereby amended as follows:

"4.5.9 If a city or municipal local government is ineligible to implement a BuB Project, the project may be implemented by the concerned participating agency. It may also be implemented by the provincial government under the following conditions:


- The provincial government has the technical capability as determined by the participating agency concerned;
- The provincial government has complied with the Good Financial Housekeeping conditions as of the latest DILG assessment;
- Submission of documents that may be required by participating agencies"


5. **REPEALING CLAUSE.** All provisions of existing issuances that are inconsistent with this Circular are hereby repealed/amended accordingly.

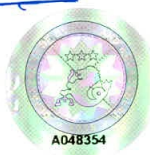
6. **EFFECTIVITY.** This circular shall take effect immediately.
