#### 1.0 BACKGROUND

National Budget Circular (NBC) No. 577 dated May 2, 2019<sup>1</sup> was issued to provide the budgetary policies relative to the release of funds for FY 2019, as well as to prescribe the procedural guidelines, including the requisite rules and regulations, on the treatment of fund releases and utilization prior to and after the approval of the FY 2019 General Appropriations Act (GAA), i.e., Republic Act (RA) No. 11260.

#### 2.0 **RATIONALE**

Relative thereto, this Circular is issued to provide the Annexes to NBC No. 577 which classify expenditure items as comprehensively released through the GAA as the Allotment Order (GAAAO) without need for clearance, and those that will require the issuance of Special Allotment Release Orders (SAROs).

- 3.0 The following Annexes<sup>2</sup> shall serve as bases of agencies to incur obligations, within their respective allowable limits, in the implementation of programs, activities, and projects, in the conduct of government operations in FY 2019:
  - 3.1 Adjusted Annexes A and A-1, reflecting agency revisions on the earlier submitted Annexes A and A-1 as attached to NBC No. 577, to wit:
    - 3.1.1 Annex A Summary of FY 2019 Appropriations; and

  - 3.3.2 Annex D Summary of Automatic Appropriations by Agency classified as FLR through SARO

#### 4.0 **SEPARABILITY**

If any part or provision of this Circular is held invalid or unconstitutional, other provisions not affected thereby shall remain in force and effect.

#### 5.0 REPEAL

All provisions of existing circulars and other issuances inconsistent with this Circular are modified accordingly.

### 6.0 **EFFECTIVITY**

This Circular shall take effect immediately.
