Subject : CONDUCT OF EXECUTIVE BRIEFINGS ON THE NATIONAL GUIDELINES ON INTERNAL CONTROL SYSTEMS (NGICS)<sup>1</sup> AND REVISED PHILIPPINE GOVERNMENT INTERNAL AUDIT MANUAL (RPGIAM)<sup>2</sup>

- 1.0 In line with the efforts of the Department of Budget and Management (DBM) to strengthen internal control systems in government, especially with respect to the conduct of internal audit as a key part thereof, and in connection to its mandate to promulgate the necessary rules and regulations thereon pursuant to various executive issuances,<sup>3</sup> a series of **executive briefings on the NGICS and RPGIAM** shall be held in four (4) batches on **19**, **21**, **26**, **and 28 July 2023**, **1:00 PM to 5:00 PM**, via Zoom.
- 2.0 The NGICS and RPGIAM briefings aim to: (i) establish the context of the roles and responsibilities of the principals of internal audit units (IAU), i.e., Department Secretaries/Heads of the Agencies/Governing Boards/Audit Committees, and senior officials in the internal control system; (ii) deepen their understanding and appreciation of their accountabilities in terms of supervision; and (iii) apprise them on the intended functions of the IAU in the conduct of a separate evaluation of a sound internal control system that will ultimately help the agency promote effective, efficient, ethical, and economical operations in government.
