**AUDIT MANUAL (RPGIAM) AS OF 28 FEBRUARY 2024** 

#### 1.0 Rationale/Background

DBM Circular Letter (CL) No. 2021-9 dated 14 October 2021<sup>1</sup> was issued to 1.1 adopt and institutionalize the Recognition Program for the resource persons on the NGICS<sup>2</sup> and RPGIAM,<sup>3</sup> and provide the corresponding guidelines therefor.

The Recognition Program has six (6) phases, i.e., recruitment, selection, learning and development, evaluation, conferment, and retention. Pursuant to item 5.6 of DBM CL No. 2021-9, the DBM shall maintain an updated list of recognized resource persons which shall be published on the DBM official website.

1.2 As part of the implementation of the Recognition Program and to expand the roster of recognized resource persons, the DBM issued a call for submission of applications through DBM CL No. 2023-9 dated 27 June 2023<sup>5</sup> and conducted the necessary activities related thereto.

Accordingly, the Batch 3 of the Training of Trainers on the NGICS and RPGIAM was conducted on select dates in October 2023. Ten (10) resource persons from seven (7) agencies have successfully completed the first four (4) phases of the Recognition Program and have been recently officially conferred with recognition on 28 February 2024.

#### 2.0 Purpose

This Circular is being issued to confirm, adopt, and approve the **updated** list of recognized resource person on the NGICS and RPGIAM to include those who were conferred with recognition on 28 February 2024, appended hereto as **Annex A**.

#### 3.0 Commitments and Obligations of the Recognized Resource Persons

The recognized resource persons shall be engaged as speakers, subject matter experts, and/or facilitators in various learning and development interventions on public sector internal control and internal audit, including the series of capacity-building training (CBT) on the NGICS and RPGIAM, following their commitments and obligations contained in the Memoranda of Understanding executed for the purpose.

To facilitate the effective fulfillment of the commitments and obligations of the recognized resource persons, the Department Secretary/Head of Agency or the Governing Board/Audit Committee of their respective agencies are respectfully requested to authorize and extend the necessary support for the participation of the recognized resource persons in various CBT activities on the NGICS and RPGIAM.

#### 4.0 **Separability**

If, for any reason, any part or provision of this Circular Letter is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

### 5.0 **Effectivity**

This Circular Letter shall take effect immediately upon publication in the Official Gazette or a newspaper of general circulation.
