This pertains to the **DOF Devolution Transition Plan (DTP)** submitted to the Department of Budget and Management (DBM) per your letter dated 08 November 2022,¹ in compliance with Executive Order (EO) No. 138² dated 1 June 2021 which directs the full devolution of functions and services to the local government units (LGUs) consistent the Local Government Code of 1991 (Republic Act No. 7160).

Per the DBM's in-depth evaluation of the submitted DOF DTP and its annexes as prescribed under EO No. 138, its Implementing Rules and Regulations, and DBM-Department of the Interior and Local Government (DILG) Joint Memorandum Circular (JMC) No. 2021-2,³ we are pleased to inform you that we find the DOF DTP to have sufficiently taken into consideration the DBM observations and recommendations,⁴ and is thus found to be in order and is hereby **approved**.

The results of our evaluation of the DOF DTP are detailed in the **attached DTP evaluation report**.
