## REVIEW AND COMPLIANCE COMMITTEE (RCC) ADVISORY NO. 2020-03

- 1.0 Pursuant to Section 8 of Republic Act (RA) No. 6713¹, Rule VII of its Implementing Rules and Regulations, and item 4.0 of the Department of Budget and Management (DBM) RCC Revised Internal Guidelines,² all DBM officials and employees are enjoined to file thru RCC not later than 31 January 2021 their respective Statement of Assets, Liabilities, and Net Worth as of 31 December 2020.
- 2.0 Please note that the said deadline applies regardless of whether the declarant is on leave of absence, on absence without leave, or on official business.
- 3.0 Accordingly, kindly submit three (3) copies of the duly accomplished 2015 SALN Form<sup>3</sup> as follows:

Officials and employees in the Central Office	Administrative Service (AS)—Human Resource Management Division (HRMD)
Officials and employees in the Regional Offices	Regional Office (RO) RCC <sup>4</sup>

- 4.0 To guide everyone, attached is a copy of the detailed instruction on the proper accomplishment of the SALN Form.
- 5.0 Further, everyone is reminded to observe the provisions of RA No. 10173<sup>5</sup> regarding the processing of personal information.
